Pointe of Grace Liability Waiver

General Liability Waiver:

I shall hold harmless, Pointe of Grace, LLC, its operator, agents, and the providers of program locations from any Liability and/or responsibility for any accident, illness, injury or loss of personal items.

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19:

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Pointe of Grace has put in place preventative measures to reduce the spread of COVID-19; however, Pointe of Grace cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending dance classes and/or camps at Pointe of Grace could increase your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by participation in dance classes and/or camps at Pointe of Grace, and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at Pointe of Grace may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Pointe of Grace employees, contractors, third party vendors, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at Pointe of Grace, or participation in Pointe of Grace classes and/or camps ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless Pointe of Grace, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Pointe of Grace, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Pointe of Grace classes or camps.
